- 25% and 30% surcharges will be applied to Level D and Level C contaminated samples, respectively.
- Sample disposal (or return) of hazardous or chlorinated contaminated soil will be charged at cost plus 15%.
- Sample shipment will be charged at cost plus 15%
- EGL will hold residual samples for 3 months after which the samples will be discarded. Charge for storage of samples beyond 30 days will be \$5 each per month.
- 100% and 75% surcharges will be applied to 24/48 hour and 72 hour expedited samples, respectively.
- Courier fee will be charged \$80.00 per trip.
